

#### MARINE SANCTUARIES

In 1972, the Marine Protection, Research, and Sanctuaries Act was enacted to help protect the offshore areas of the United States. In 1980, Title III of the Act was amended to enable the Secretary of Commerce, with Presidential approval, to propose designation of ocean waters as national marine sanctuaries. Its purpose is to preserve or restore areas for their conservational, recreational, ecological or aesthetic value.

As of June 1990, there are 8 national marine sanctuaries and 10 proposed sites. These extend from as far west as Fagatele Bay in the American Samoa to as far east as Key Largo in Florida.

This brief bibliography is intended to provide a selected guide to recent literature on marine sanctuaries together with original government studies on the different sites. The items are arranged alphabetically by author under four separate categories. Those items with a call number indicate that the NOAA Central Library holds them. Current references were selected from Aquatic Sciences and Fisheries Abstracts, GPO Monthly Catalog, NTIS, Biological Abstracts, and various smaller databases.
