Fishermen of the Greater Tampa Bay VOICES FROM THE FISHERIES Oral History

For the last three school years, Southeast Regional Office anthropologists and a local school, Admiral Farragut Academy, have partnered to implement a Voices from the Fisheries' Local Fisheries Knowledge Project to conduct oral histories. Marine science students developed interview questions and conducted interviews with members of the commercial and recreational fishing sectors in Florida's greater Tampa Bay area.

A total of 27 oral histories of private recreational anglers, for-hire captains, commercial fishermen, fish dealers, fishing support business owners, and fisheries employees have been gathered through this project thus far.

Approximately 67 students have taken part in the project as interviewers, interviewing in teams of three to five students. The project provides meaningful learning opportunities for students and helps to preserve fishing history.



AMENDMENT 41

Allocation-Based Management for Federally Permitted Charter Vessels

This amendment explores allocation-based management programs to reduce uncertainty, improve economic conditions, and increase fishing opportunities for federally permitted charter vessels and their passengers. Two options (an individual fishing quota and a permit fishing quota program) and five selected species (red snapper, greater amberjack, gray triggerfish, gag, and red grouper) are being considered. The Gulf Council will review a decision tool and consider preferred alternatives at the April Gulf Council meeting.

Similar to Amendment 41. Amendment 42 considers allocation-based management for federally permitted for-hire vessels that have a landings history through the Southeast Region Headboat Survey. Five species are considered for inclusion: red snapper, greater amberjack, gray triggerfish, gag, and red grouper. The Gulf Council requested a decision tool for stakeholders to review the range of alternatives. The Gulf Council will review and select preferred alternatives at the April Gulf Council meeting.

AMENDMENT 36A: OPEN FOR COMMENTS

Commercial IFQ Program Modifications

This amendment would establish hail-in requirements for all commercial reef fish permitted vessels (3-24 hours advance notice and landing only at an approved location), returning shares from non-activated IFQ accounts, and retaining annual allocation before a quota reduction. NOAA Fisheries is taking comments on the proposed rule through April 23.

GROUPER-TILEFISH 5-YEAR REVIEW

The Gulf Council and NOAA Fisheries are conducting the first five-year review of the Grouper-Tilefish IFQ program. Several presentations of analyses, studies, and surveys have been given to the Council and Science and Statistical Committee. The Gulf Council will review a draft document at the April Gulf Council meeting. A presentation will also be given to the Gulf Council at their April meeting.

AMENDMENT 36B Commercial IFQ Program Modifications

Considers updates to the IFQ programs' goals and objectives based on the Red Snapper IFQ 5-year review and the upcoming Grouper-Tilefish IFQ 5-Year review. The current actions consider program participation requirements, restrictions for public participants, quota redistribution of future quota increases, distribution of revoked shares from non-activated accounts, restrictions on share and allocation transfers, and creation of a red snapper allocation cap.

WRECKFISH REVIEW

The South Atlantic Council and NOAA Fisheries are conducting the second review of the Wreckfish Individual Transferable Quota (ITQ) program. The review will compare results from 2009/2010 - 2011/2012 fishing years to the most recent fishing years 2012/2013-2016/2017. This review will evaluate the effectiveness of the program, and provide conclusions and recommend changes to the ITQ program. Council action will be required to make any changes to the program through the normal amendment process.

Individual Bluefin Tuna Quota Program

Fisheries implemented the Individual Bluefin Tuna Quota (IBQ) program in 2015 as a way to reduce and fully account for dead discards in the pelagic longline fishery, prevent overfishing, and rebuild the Atlantic Bluefin tuna stock. Bluefin tuna can be encountered as bycatch on pelagic longlines that are targeting swordfish or yellowfin or bigeye tunas. This innovative program differs from other catch share programs as the reporting and allocation requirements are solely for the bycatch of bluefin tuna rather than the targeted fishery (i.e., other tunas or swordfish). All pelagic longline vessel owners must account for bluefin tuna landings and dead discards using IBQ allocation. The program requires that for the first pelagic longline trip in each calendar quarter, a vessel must have a minimum amount of allocation before departing on a fishing trip.

One of the successes of the IBQ program is a dramatic reduction in dead discards. Discards have been reduced greater than six-fold from over 130 mt to less than 23 mt (Table 1). A full evaluation of the program, including the effect on the economics of the fishery will be completed in an upcoming 3-year review. The review will also look at the effects of the design of initial share distribution. This program serves as a model of how catch shares can be designed and applied to different fisheries to address a specific fishery issue.
