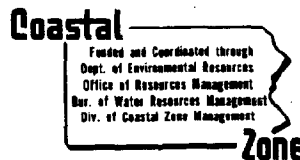

The report is a summary of the work accomplished under a grant from the Pennsylvania Coastal Zone Management Program under the provisions of Coastal Zone Management, Bureau of Water Resources management, Pennsylvania Department of Environmental Resources.

INTRODUCTION

The Delaware County Conservation District has had an agreement in effect since 1981 to implement the State's Erosion and Sediment Control Program. This program is based on Chapter 102 - Erosion Control, which is the Department of Environmental Resources' rules and regulations for the implementation of the PA. Clean Streams Law in regards to sediment pollution. The database that was developed as part of this project was necessary to improve our ability to administer this program.

The database has greatly expanded our capabilities in researching information collected during the review of erosion and sediment control plans. The 40 meg Hard Disk that was determined to be needed by Computer Consultant - Dan Reinhold, working for the Bureau of Soil and Water Conservation permits us to store this information in one location. We can produce, on demand, information such as the number of project proposed for construction in a single watershed, the total proposed acreage of new projects, projects in a watershed that proposed construction of stormwater detention basins, basic information on proposed land Use, etc.

The project which also provided for the purchase of a new computer has proven to be a very wise decision. Our existing Tandy 2000 computer has been discontinued, and is approximately 5 years old. It remains in active use by the Secretary of the District strictly for word processing. The new machine a Tandy 3000 is the machine the computer consultant for the B.S.W.C. has selected as the highest level machine that will currently be supported by the Bureau of Soil & Water Conservation. Delaware County now has a computer capable of handling any software currently being used by Pennsylvania Conservation Districts.

DATABASE CONTENTS

The following list illustrates the organization of the Database. The software used to create this database is R-Base 5000 by Micro-rim. This software was selected by the Bureau of Soil & Water Conservation's Computer Consultant, and was provided to us through an agreement with the U.S.D.A. Soil Conservation Service.

All reviews conducted by either the Soil Conservation Service or the Delaware County Conservation District since January 1, 1981 have been entered into the database. A file by file research of all plans prior to January of 1986 was performed to fill in information that was not collected during the time the plan was reviewed. This was a very time consuming project. It was a very valuable effort, however because we now have a database with over 664 entries which contains a wealth of information not previously available.

DATABASE MANAGEMENT

The information which goes into the database is collected as part of our erosion and sediment control plan review process. Plans are submitted to the Delaware County Conservation District for several reasons 1. The Developer has concerns about specific environmental issues 2. The Local Municipality requires our review. 3. Our review is required before a State permit can be issued. 4. The County Planning Department received the plan during their review process.

The Database also provides a mechanism to produce monthly reports that are required for presentation at our monthly Conservation District Director's meetings. This monthly report system is much easier to use than the previous method. A copy of one of these reports is included in the appendix.

Due to the State now utilizing zero-balance budgeting all information on work accomplished as a result of our erosion and sediment control plans will be essential. This assures that the database will remain in operation for many years to come.

PROJECT OBJECTIVE

The primary goal of this project was to provide the Conservation District with a working database that would be capable of the following :

1. Assist the Conservation District in the analysis of construction and earthmoving trends.
2. Assist us in locating probable sources of sediment when investigating sediment pollution reports.
3. Develop a list of projects with stormwater management basins, as needed during the development of Stormwater Management Plans as required by Act 167.
4. Make long term planning decisions on whether or not permit requirements should be altered in critical watersheds.
5. Serve as a model for the other 65 Conservation Districts in Pennsylvania.
6. Keep tract of plans on file to assist local municipalities in dealing with post development questions.

In the opinion of the writer all these objectives and more have been made possible as a result of this project. The project also has kept us up to date with necessary equipment. Our previous computer is no longer on the market, and the last ones were recently sold for \$210.00 each. The B.S.W.C. Bureau of Soil and Water Conservation, D.E.R. has recently revised its recommended minimum computer equipment standards. We now have the latest technology recommended.

The computer system and database has improved both our office credibility and capabilities. We can produce reports at the request of engineering firms, local municipalities, and governmental agencies which otherwise would not have been possible.

FUTURE PLANS

As a result of this project I have been appointed to a committee which has been assigned the task of developing a similar database system for the entire State of Pennsylvania. Although the database I have created will need to be revised to meet the information requirements of the Bureau of Soil & Water Conservation. The database program R-Base 5000 is flexible enough to permit this modification without losing any information. Completion of this project has given the Delaware County Conservation District a significant jump on the rest of Pennsylvania. This experience will help greatly in the development of a database system for the entire state of Pennsylvania.

The database will continue to be added to monthly. The monthly agenda report involving erosion and sediment control plan reviews is now easily developed by the computer. This report is shown in the appendix.
