This report provides bycatch estimates, calculated by using mortality and serious injury counts combined, for 6 cetacean and 2 pinniped species incidentally captured by Northeast bottom trawl (NEBT) and Mid-Atlantic bottom trawl (MABT) fishing operations from 2014 to 2018 (Table 1). The data presented here are an update from Lyssikatos et al. (2019) and Chavez-Rosales et al. (2018) which covers the fishing operations from 2012 to 2017. The bycatch estimation methodology does not differ from earlier years dating back to 2008 (Lyssikatos 2015; Chavez-Rosales et al. 2017). Stratified bycatch estimates were produced by using a ratio estimator by region, year, trimester, and ecoregion (Table 2). For details on the bycatch estimation methodology, please refer to recent documentation in Chavez-Rosales et al. 2018. The marine mammal species included for the 2014-2018 time period are: Atlantic white-sided dolphin (Lagenorhynchus acutus), common dolphin (Delphinus delphis delphis), common bottlenose dolphin- offshore stock (Tursiops truncatus truncatus), Risso's dolphin (Grampus griseus), longfinned pilot whale (Globicephala melas), harbor porpoise (Phocoena phocoena), harbor seal (Phoca vitulina vitulina), and gray seal (Halichoerus grypus atlantica). The aim of this report is to document bycatch estimates for the 5-year period 2014 through 2018 to support the US Atlantic and Gulf of Mexico 2020 marine mammal stock assessment reports. The 2014 to 2018 NEBT estimates are based on observed bycatch (mortalities and injured animals) consisting of 12 white-sided, 13 common, 2 Risso's, and 7 offshore bottlenose dolphins, 1 harbor porpoise, 9 pilot whales, and 3 harbor and 15 gray seals. MABT estimates are based on observed bycatch consisting of 1 white-sided, 187 common, 17 Risso's, and 8 offshore bottlenose dolphins, and 3 harbor and 16 gray seals. (Table 3; Figure 1). Refer to Josephson et al. (2019) for details on injury determinations attributed to interactions with bottom trawl gear. The final 2018 serious injury determinations will be published at a later date.

Mean annual bycatch estimates from the NEBT fishery were 16.54 (coefficient of variation [CV] = 0.26) common dolphins, 4.18 (CV = 0.73) Risso's dolphins, 12.16 (CV = 0.36) long-finned pilot whales, 1.10 (CV = 0.86) harbor porpoises, 14.71 (CV = 0.26) Atlantic white-sided dolphins, 10.42 (CV = 0.62) offshore common bottlenose dolphins, 17.80 (CV = 0.24) gray seals, and 3.80 (CV = 0.55) harbor seals. Mean annual bycatch estimates in the MABT fishery were 268.21 (CV = 0.13) common dolphins, 28.68 (CV = 0.31) Risso's dolphins, 12.08 (CV = 0.39) offshore common bottlenose dolphins, 1.93 (CV = 0.94) Atlantic white-sided dolphins, 23.06 (CV = 0.33) gray seals, and 4.53 (CV = 0.57) harbor seals (Table 1). Total annual bycatch estimate and composite coefficient of variation for each species and annual estimate are shown in Table 1. There was no significant change in temporal or spatial bycatch patterns attributed to NEBT and MABT gear among the species described in this report (Figures 2-3), comparable to interannual values reported in Chavez-Rosales et al. (2017, 2018) and Lyssikatos (2019).

Observer coverage, defined as the percentage of the vessel trip report (VTR) trips in which an observer was on board a fishing vessel, averaged 14.92% for the Northeast (NE), ranging from 12.12% for 2016 with a maximum coverage of 19.30% in 2014. For the Mid-Atlantic (MA) region, average coverage was 10.62%, ranging from 8.99% for 2014 with a maximum coverage 13.93% in 2017 (Table 2). Mean annual observer coverage continued to be higher in the NE compared to the MA because of the allocation of at-sea monitors in addition to traditional fisheries observers in the NE region.

es\_Sector\_ASM\_Requirements\_Summary.pdf. However, observer coverage in MABT fisheries did increase during the 2014 to 2018 time period as a result of increased allocation of observer sea days to monitor bycatch of sea turtles and federally-regulated species (NEFSC and GARFO 2019).




Figure 1. Incidental take locations from the observed commercial trips in the Northeast and Mid-Atlantic study areas 2014-2018 for Atlantic white-sided dolphin (*Lagenorhynchus acutus*), common dolphin (*Delphinus delphis delphis*), long-finned pilot whale (*Globicephala melas*), offshore common bottlenose dolphin (*Tursiops truncatus truncatus*), Risso's dolphin (*Grampus griseus*), harbor seal (*Phoca vitulina vitulina*), harbor porpoise (*Phocoena phocoena phocoena*), and gray seal (*Halichoerus grypus atlantica*). The strata were delimited by the 70°W longitude.




Figure 2. Annual bycatch mortality estimates (lognormal 95% Confidence interval) for bottom trawl gear by region, species and year in Northeast and Mid-Atlantic commercial bottom trawl trips, 2014-2018. Wd = Atlantic white-sided dolphin (*Lagenorhynchus acutus*), Cd = common dolphin (*Delphinus delphis delphis*), Pw = long-finned pilot whale (*Globicephala melas*), Bd = offshore common bottlenose dolphin (*Tursiops truncatus truncatus*), Rd = Risso's dolphin (*Grampus griseus*), Hp = harbor porpoise (*Phocoena phocoena phocoena*), Gs = gray seal (*Halichoerus grypus atlantica*), and Hs = harbor seal (*Phoca vitulina*).




Figure 3. Bycatch mortality estimates for 2014-2018 in Northeast and Mid-Atlantic commercial bottom trawl trips stratified by ecoregion, year, season (w = January-April, s = May-August, f = September-December), and species (Atlantic white-sided dolphin [*Lagenorhynchus acutus*], common dolphin [*Delphinus delphis delphis*], long-finned pilot whale [*Globicephala melas*], offshore common bottlenose dolphin [*Tursiops truncatus truncatus*], Risso's dolphin [*Grampus griseus*], harbor porpoise [*Phocoena phocoena phocoena*], gray seal [*Halichoerus grypus atlantica*], and harbor seal [*Phoca vitulina vitulina*]).

#### Clearance

All manuscripts submitted for issuance as CRDs must have cleared the NEFSC's manuscript/abstract/ webpage review process. If any author is not a federal employee, he/she will be required to sign an "NEFSC Release-of-Copyright Form." If your manuscript includes material from another work which has been copyrighted, then you will need to work with the NEFSC's Editorial Office to arrange for permission to use that material by securing release signatures on the "NEFSC Use-of-Copyrighted-Work Permission Form."

For more information, NEFSC authors should see the NEFSC's online publication policy manual, "Manuscript/abstract/webpage preparation, review, and dissemination: NEFSC author's guide to policy, process, and procedure," located in the Publications/Manuscript Review section of the NEFSC intranet page.

#### Organization

Manuscripts must have an abstract and table of contents, and (if applicable) lists of figures and tables. As much as possible, use traditional scientific manuscript organization for sections: "Introduction," "Study Area" and/or "Experimental Apparatus," "Methods," "Results," "Discussion," "Conclusions," "Acknowledgements," and "References Cited."

#### Style

The CRD series is obligated to conform with the style contained in the current edition of the United States Government Printing Office Style Manual. That style manual is silent on many aspects of scientific manuscripts. The CRD series relies more on the CSE Style Manual. Manuscripts should be prepared to conform with these style manuals.

The CRD series uses the American Fisheries Society's guides to names of fishes, mollusks, and

decapod crustaceans, the Society for Marine Mammalogy's guide to names of marine mammals, Integrated Taxonomic Information System guidance on scientific and common names for all other species, the Biosciences Information Service's guide to serial title abbreviations, and the ISO's (International Standardization Organization) guide to statistical terms.

For in-text citation, use the name-date system. A special effort should be made to ensure that all necessary bibliographic information is included in the list of cited works. Personal communications must include date, full name, and full mailing address of the con-tact.

#### Preparation

Once your document has cleared the review process, the Editorial Office will contact you with publication needs – for example, revised text (if necessary) and separate digital figures and tables if they are embedded in the document. Materials may be submitted to the Editorial Office as email attachments or intranet down- loads. Text files should be in Microsoft Word, tables may be in Word or Excel, and graphics files may be in a variety of formats (JPG, GIF, Excel, PowerPoint, etc.).

#### **Production and Distribution**

The Editorial Office will perform a copyedit of the document and may request further revisions. The Editorial Office will develop the inside and outside front covers, the inside and outside back covers, and the title and bibliographic control pages of the document.

Once the CRD is ready, the Editorial Office will contact you to review it and submit corrections or changes before the document is posted online.

## Publications and Reports of the Northeast Fisheries Science Center

The mission of NOAA's National Marine Fisheries Service (NMFS) is "stewardship of living marine resources for the benefit of the nation through their science-based conservation and management and promotion of the health of their environment." As the research arm of the NMFS's Northeast Region, the Northeast Fisheries Science Center (NEFSC) supports the NMFS mission by "conducting ecosystem-based research and assessments of living marine resources, with a focus on the Northeast Shelf, to promote the recovery and longterm sustainability of these resources and to generate social and economic opportunities and benefits from their use." Results of NEFSC research are largely reported in primary scientific media (*e.g.*, anonymously-peerreviewed scientific journals). However, to assist itself in providing data, information, and advice to its constituents, the NEFSC occasionally releases its results in its own media. Currently, there are three such media:

*NOAA Technical Memorandum NMFS-NE* -- This series is issued irregularly. The series typically includes: data reports of long-term field or lab studies of important species or habitats; synthesis reports for important species or habitats; annual reports of overall assessment or monitoring programs; manuals describing program-wide surveying or experimental techniques; literature surveys of important species or habitat topics; proceedings and collected papers of scientific meetings; and indexed and/or annotated bibliographies. All issues receive internal scientific review and most issues receive technical and copy editing.

*Northeast Fisheries Science Center Reference Document* -- This series is issued irregularly. The series typically includes: data reports on field and lab studies; progress reports on experiments, monitoring, and assessments; background papers for, collected abstracts of, and/or summary reports of scientific meetings; and simple bibliographies. Issues receive internal scientific review and most issues receive copy editing.

*Resource Survey Report* (formerly *Fishermen's Report*) -- This information report is a regularly-issued, quick-turnaround report on the distribution and relative abundance of selected living marine resources as derived from each of the NEFSC's periodic research vessel surveys of the Northeast's continental shelf. This report undergoes internal review, but receives no technical or copy editing.
