HOW TO USE THE MARINE BILLS '78 DIGEST

This final publication of the Marine Bills '78 series is a more comprehensive effort than the previous newsletters. It includes a brief summary of all marine-related Acts approved in 1978, adopted Resolutions, and a listing of marine-related line items from the 1978 Supplemental Budget Appropriations.

Acts are listed in numerical order. For quick reference, an index of the Acts is located on page 12. Resolutions are subdivided first by subject matter, then by legislative body (ie. House or Senate) and finally arranged in numerical order. Supplemental Appropriations line items are subdivided into broad subject categories, then listed alphabetically.

The following abbreviations indicate the type of legislative measure, and where it originated:

HB - House Bill

SB - Senate Bill

HR - House Resolution

SR - Senate Resolution

HCR - House Concurrent Resolution

SCR - Senate Concurrent Resolution

Amendments

The draft number of a bill reflects the number of times it has been amended. The first two letters of the draft number will be one of three possibilities:

HD - House Draft

SD - Senate Draft

CD - Conference Draft

The number following these letters indicates how many times a bill was amended in a particular legislative body. For example, SD 2 means that a bill was amended twice in the Senate. When the House and Senate cannot agree on the final draft of a bill, selected members from each body form a joint committee and attempt to resolve their differences. The draft which results from the efforts of this conference committee is indicated as CD 1.

Committee Reports

Attached to every draft of any bill is a copy of the committee report, which usually states the purpose of the bill and possible impacts if approved. Since there are often several drafts of a bill, they are filed by committee report number, NOT by bill number. For this reason, the committee report numbers are included for every Act and Resolution listed in this publication.

How to get copies of bills and their committee reports

When requesting copies from any office in the Capitol Building, it is more convenient for all concerned if they are asked for by committee report number. At the State Archives, bills are filed by bill number; therefore, it is easier to ask for them by bill number.

ACTS APPROVED IN 1978

Act 36 RELATING TO COUNTY PARTICIPATION IN THE DEVELOPMENT OF ALTERNATE ENERGY RESOURCES

Act 36 amends Chapter 46, Hawaii Revised Statutes, by adding a new section which encourages the counties to participate in the development of alternate energy resources and the production and distribution of energy. Under the amended Chapter, each county is allowed to engage in joint ventures with an end user or a public utility for the purpose of developing alternate energy resources such as geothermal, solar, wind, ocean, biomass or solid waste energy. If there is no "partner" available, the counties may proceed with the development of these resources for their own consumption, an end user or a public utility.

Act 72 RELATING TO MANDATORY CERTIFICATION OF PUBLIC UTILITIES

This Act adds a new section to Chapter 269, Hawaii Revised Statutes (dealing with public utilities), which provides that no person intending to construct or operate a public utility will begin business without first obtaining a "certificate of public convenience and necessity" from the Public Utilities Commission. The amended chapter will insure that persons entering into the public utility business are financially fit and will be able to adequately perform their proposed service. The Act also contains a provision which requires the public utility to secure P.U.C. approval before abandoning the service. Reference: HB 1934, SD 1

Act 76 RELATING TO THE BURDEN OF PROOF IN CONTESTED CASES

Act 76 amends the Administrative Procedures Act to provide that the party initiating a contested case will bear the burden of proof, which includes the responsibility of producing evidence as well as the burden of persuasion. In previous cases before the various State regulatory bodies, it had not been clear where the burden of proof lay. As a result, the various bodies have adopted requirements which are not consistent with each other. This Act adopts the same standards as those of the Federal Administrative Procedures Act, and gives the State regulatory boards some uniformity.

Act 81 RELATING TO THE AUTHORIZATION OF AIRPORT AND HARBOR REVENUE . BONDS

This Act amends Section 93 and 93A of Act 195, Session Laws of Hawaii, by authorizing substitutions of airport and harbor revenue bonds in place of general obligation bonds. There is concern that the State may have to curtail the issuance of general obligation bonds; and there are still certain essential Capital Improvement Program (C.I.P.) projects for airports and harbors which must be funded. This Act, therefore, insures that the necessary projects will receive funding. Reference: HB 3051

Act 82 RELATING TO THE REPOSSESSION OF VESSELS UNDER LEGAL CUSTODY

This Act adds a new section to the harbors law, now making it illegal for any person to repossess a vessel or property under legal custody of the State Department of Transportation (D.O.T.). It is sometimes necessary for the D.O.T. to take derelict or abandoned vessels, freights with unpaid charges, and other articles into custody, under the authority of Chapter 266 or 267A, Hawaii Revised Statutes. Prior to this amendment, the D.O.T. had trouble taking legal action when the owners of the seized vessels or property would "steal them back," by removing them from the area where they had been stored. Act 88 RELATING TO AQUACULTURE LOANS

Act 88 amends Sections 219-4 and 219-5, Hawaii Revised Statutes, by establishing a \$1,000,000 ceiling on the State's liability for insuring loans made to aquaculturalists from private lenders. The amendment will help to prevent further complications with with State insurance of loans. In addition, a new subsection (12) was added to 219-5, H.R.S., which assures that a proper reserve will be maintained in the aquaculture loan revolving fund to guarantee any payments of defaults on insured loans.

Act 94 RELATING TO BOAT NOISE

This Act amends the law relating to noise pollution (Section 342-41) by expanding the definition of "vehicle" to include boats and ships. The Department of Health, in cooperation with the Department of Transportation, will develop regulations governing boat noise emissions that are as close as practicable

to the Community Noise Code for Oahu. The Act also amends Section 342-42, which enables the Director of Health to commission the preparation and distribution of information relating to the effect of excessive noise on people.

Act 97 RELATING TO THE DEFINITION OF THE "LEEWARD ISLANDS OF THE STATE"

This Act amends Section 188-37, Hawaii Revised Statutes, by expanding the definition of "Leeward Islands of the State" as "beginning and including Nihoa" (rather than French Frigate Shoal). The amendment also includes all appurtenant reefs (such as reefs which are partially submerged) and all territorial waters between Nihoa Island and Kure Island.

The State of Hawaii is presently engaged in negotiations with the United States Department of the Interior to define the respective jurisdictions of the State and Federal governments in the Leeward Islands. These negotiations have not yet reached a satisfactory conclusion. Section 2 of the Organic Act of 1900 and Section 2 of the Admission Act of 1959 included the Leeward Islands as part of Hawaii. However, in 1909 President Theodore Roosevelt, under Executive Order 1019, ordered that certain "islets" and "reefs" of the Leeward Island chain be "reserved and set apart, subject to valid existing rights, for the use by the U.S. Department of Agriculture as a preserve and breeding ground for native birds." (Emphasis added.) Based on the Organic Act of 1900 and the Admission Act of 1959, there is a possibility that the State retains an ownership interest in the Leeward Islands. The U.S. Department of the Interior, however, is supporting legislation in the U.S. Congress that proposes to place all Leeward Islands, their appurtenant reefs and territorial waters under the jusisdiction of a National Wildlife Preservation System, controlled by the Interior Department.

The passage of this Act is a statement that the State is totally serious in its claim to jurisdiction over all the Leeward Islands. At the same time, the Act will allow the Department of Land and Natural Resources to expand its fishing regulations to include Nihoa and Necker, as these two islands appear to have great fishery potential.

Act 100 RELATING TO STATE PLANNING

Act 100 repeals Chapter 225, Hawaii Revised Statutes, and adds a new chapter entitled the "Hawaii State Planning Act,"

which is intended to serve as a guide for future development in the State. It identifies State goals, objectives and policies; and provides the basis for determining priorities and the allocation of various limited resources throughout the State (for example, public funds and services, land, energy, water).

The 5 basic parts of the statewide planning system which coordinate all major state and county activities are:

- State Functional Plans must conform to the State Plan, be formulated using the County Plans as a basis, and must be adopted by a concurrent resolution of the Legislature.
- 2. County General Plans all must conform to the State Plan by 1982 and be formulated using the State Functional Plans which have been adopted by the Legislature as a basis.
- 3. State Programs must conform to the State Plan.
- 4. Advisory Committees established to assist state agencies in the preparation of functional plans.
- 5. Policy Council established to advise the Legislature on overall planning concerns. Staff assistance to the Council will be provided by the Department of Planning and Economic Development.

The State Plan specifies policies for many different areas of concern such as population planning, visitor industry, transportation and natural resources. Some of the policies related to land-based, shoreline and marine resources are:

- 1. Establish an overall conservation ethic in the State.
- 2. Ensure compatability between land-based and water-based activities with natural resources and ecological systems.
- 3. Protect rare or endangered plant and animal species.
- 4. Provide public incentives to encourage private actions to protect significant natural resources.

Act 131 RELATING TO THE AUTHORIZATION OF GENERAL OBLIGATION BOND FUNDS FOR RESEARCH ON ALTERNATE ENERGY RESOURCES

Act 131 appropriates \$3,845,000 out of general obligation bond funds for research on the development and utilization of alternate energy resources. Specific breakdowns are as follows: biomass energy - \$1,530,000; geothermal energy - \$200,000; ocean energy \$1,225,000; solar/wind energy - \$890,000. This authorization lapses on June 30, 1982.

Act 132 RELATING TO GEOTHERMAL ENERGY RATES

This Act provides that geothermal energy rates paid by public utilities to the producers of such energy will be established by an agreement between the utility and the producer, subject to the approval of the Public Utilities Commission. If no agreement can be reached, the Public Utilities Commission will set the rate. This Act intends to encourage the commercial development of geothermal energy by ensuring reasonable rates. ACT 135 RELATING TO THE LEASING OF PUBLIC LANDS FOR THE PURPOSE OF THE DEVELOPMENT OF GEOTHERMAL ENERGY RESOURCES

This Act amends various parts of Chapter 182, Hawaii Revised Statutes (relating to the leasing of public lands to private parties for mining purposes), thereby providing enabling legislation to support proposed rules and regulations regarding the exploration and development of geothermal energy resources. The amended Act will prevent speculation and monopoly by giving the Board of Land and Natural Resources the discretion to place a limitation on the number of leases or acres which may be held by one party. The board is also given the power to require lessees to cooperatively develop geothermal resources, in order to prevent waste.

Act 136 RELATING TO THE POSITION OF ENERGY RESOURCES COORDINATOR

This Act eliminates the position of Energy Resources Coordinator in the Office of the Governor. Instead, the Act provides that the Director of the Department of Planning and Economic Development will serve as the Coordinator. Rule-making powers, under the Administrative Procedures Act (Chapter 91, Hawaii Revised Statutes) will now apply to the Energy Resources Coordinator, provided that all proposed rules be submitted for legislative review.

Act 154 RELATING TO BEVERAGE CONTAINERS

Act 154 amends the litter control law which prohibits the selling of metal beverage containers constructed so that "a part of the container is permanently detached in opening that container." (For example, pull-tabs.) The amendment now allows for the sale of beverage containers with a pressure sensitive strip being the only detachable piece. The amendment becomes effective upon its approval.

Act 161 RELATING TO THE RESPONSIBILITIES OF THE DIRECTOR OF THE OFFICE OF ENVIRONMENTAL QUALITY CONTROL

The purpose of this Act is to clarify the authority and responsibilities of the Director of the Office of Environmental Quality Control. It essentially removes the responsibility of the Director to monitor ecological, environmental and social conditions in the State.

Act 164 RELATING TO FISHING ALONG THE ALA WAI CANAL

This Act amends Section 188-35, Hawaii Revised Statutes, by providing that any person may catch up to 50 tabai (mosquito fish), o'opu akupa, tilapia or any combination of the above per day for non-commercial purposes at the Ala Wai Canal. A single small mesh net must be used to catch the fish; the dimensions, including the handle, must not exceed 3 feet in any dimension. Reference: HB 2402, HD 1

Act 169 RELATING TO THE MANDATORY CERTIFICATION OF WASTEWATER TREATMENT PLANT OPERATORS

Act 169 establishes mandatory certification of operating personnel in wastewater treatment plants. The purpose is to assure efficient operation and maintenance of these facilities. Most private treatment plants are inadequately operated which has resulted, in a few instances, in public health hazards. This Act attempts to correct these problems through the establishment of a board of certification, consisting of 9 appointed members. The board will adopt the basis for a classification system of all public and private wastewater treatment plants in the State. At the same time, the board will establish required qualifications (based on a combination of experience and

schooling) for personnel. Private sewage treatment plants with actual flows greater than 2.0 million gallons per day are exempt from the provisions of this Act if they have a valid discharge permit and no previous record of permit violations. Cesspools and septic tanks connected with individual households are also exempt; so are industrial facilities for treatment of process water from oil refineries and sugar mills if their waste streams contain no human waste and if they do not discharge into a municipal collection, treatment or disposal system.

Act 170 RELATING TO THE BOND FUNDING OF RESOURCE RECOVERY PLANTS

This Act mandates that the counties may grant pollution control bond funding to private parties for the purpose of building resource recovery projects. This will allow private corporations to finance the cost of a resource recovery facility with tax exempt bonds, and to take advantage of lower interest rates and federal tax benefits which are only available to the private sector. Thus, the construction and operation of resource recovery facilities are encouraged through this Act. It further provides that any goods or commodities from the resource recovery plants (scrap metal or energy, for example) may be sold to registered public utilities, industrial or commercial organizations, counties or county agencies—but not to the general public.

Act 171 RELATING TO THE ESTABLISHMENT OF A CONSERVATION AND RESOURCES ENFORCEMENT PROGRAM

Act 171 creates a new chapter under Title XII, Hawaii Revised Statutes, which establishes a Conservation and Resources Enforcement Program within the Department of Land and Natural Resources. Prior to the adoption of this Act, enforcement responsibilities were split among five divisions, as well as in the Planning Office of D.L.N.R. This Act will consolidate and coordinate the Department's enforcement of laws, rules and regulations relating to the conservation of resources. In addition, this Act will allow the consolidation of various services to the public by placing within the Conservation and Resources Enforcement Program the responsibility for advise, guidance, and permits relating to hunting, fishing, camping, hiking and other recreational activities conducted on State lands.

Act 187 RELATING TO FUNDING GRANTS TO FINANCE THE CONSTRUCTION OF WATER POLLUTION CONTROL FACILITIES

Act 187 amends Section 342-34, Hawaii Revised Statutes, in order to expand the eligibility for applicants to obtain funding grants for the construction of water pollution control facilities. The Act provides more flexibility for the funding of sewer or waste treatment plants under Hawaii's environmental quality law. The new provisions require the applicant (a state or county agency) to pay 60% of the non-federal share of the estimated construction cost of the water pollution control project. The requirement enables the State of Hawaii to become eligible for 85% federal funding, under the Clean Water Act of 1977. If federal funds are not available, the Director of Health may make grants to state and county agencies for up to 100% of the estimated construction cost.

ACT 191 RELATING TO PUBLIC LANDS LEASED BY AQUACULTURALISTS

Act 191 expands the power of the Board of Land and Natural Resources to extend the terms of public land leases to include those lands leased to aquaculturalists and mariculturalists. The Board has the power to: (a) modify or eliminate restrictions imposed by the public land lease law; (b) extend or modify the fixed rental period of that lease; (c) extend the term of the lease as necessary to qualify that lease for mortgage or private loans. This Act will make it easier for aquaculturalists and mariculturalists to obtain loans from private lenders who previously would have been reluctant to grant loans to businesses holding short term land leases.

The Aquaculture Planning Program has identified approximately 650,960 acres of land which would be suitable for aquafarming. It is estimated that many thousands of these acres are public lands. The leasing of these lands, therefore, is expected to play a major role in aquaculture development. Reference: HB 2837

Act 231 RELATED TO LICENSING OF STATE VESSEL PILOTS

The intent of this Act is to provide maximum safety for vessels navigating in State waters and to help maintain a highly efficient State pilotage system. The latter intention is accomplished through the creation of a Board of Pilot Commissioners within the Department of Regulatory Agencies. The Act removes State vessel pilots from Civil Service regulation and places them under the jurisdiction of the newly established board. Prior to the approval of this Act, vessel pilots faced many problems associated with a Civil Service system. For

example, the pilots work on a 24-hour basis, which conflicts with the Civil Service working rule that requires State employees to work during specified 8-hour time slots. The Board of Pilot Commissioners, therefore, provides more flexibility for the pilots regarding the scheduling of working hours.

The Board has the power to:

1. Adopt, revise and amend rules under the Administrative Procedures Act, which may include the establishment of licensing examinations and the suspension or revocation of pilot licenses.

2. Hear and decide on any written complaints made against vessel pilots for neglect, misbehavior or breach of

rules.

3. Administer oaths and call witnesses to hearings.

The Act also clarifies the Department of Transportation's responsibility for the safety of all ports and shore waters. Reference: SB 893, SD 2, HD 1, CD 1

APPROPRIATIONS

The bulk of the 1978-79 appropriations are contained in Acts 243 and 244. Appropriations requested by the Governor are authorized by Act 243 (HB 3039, SD 1, HD 1, CD 1), which essentially amends Act 10 (the biennium budget approved in 1977), thereby providing additional funds for State and County programs. Act 244 (SB 2202, SD 1, HD 1, CD 1) was initiated by the legislators--each one requesting Capital Improvement Program funds for his/her own district.

ACT 243

Act 243 is divided into six sections, with the majority of the appropriations being in two of these: Program Appropriations in Section 3 and Capital Improvement Programs in Section 5. Program appropriations are for "operating expenses" of State and, to an extent, County agencies. These appropriations, as listed in Section 3 of Act 243, are very general, giving no indication of the manner in which they will be spent. In order to give the reader a better idea of those funds which have been "earmarked," this working paper includes three listings that provide some "breakdowns." The three listings for "earmarked" operating funds are: (1) Program Appropriations Line Items (page 26), (2) Special Program Appropriations (page 27), and Program Provisions (page 28). A brief explanation precedes each of these listings.

The Program Appropriations in Act 243 lapse at the end of the fiscal year, June 30, 1979. Capital Improvement Program appropriations lapse on June 30, 1982.

ACT 244

Act 244 consists exclusively of Capital Improvement Programs, which are always related to the construction or physical improvement of a facility (ie. harbor, park, building, flood control.) Each year, the senators and representatives of the various districts form informal committees in order to jointly request C.I.P. funds for improvements in their own district. The total appropriation for C.I.P. projects in Act 244 is \$54,899,000. The lapse date for these funds is June 30, 1982.

Every item identifies the expending agency (the agency which will spend the funds), which is listed on the top line, in parentheses. The abbreviations indicate:

It must be emphasized that although the appropriations in Acts 243 and 244 have been approved, there is no assurance that every project listed will actually be funded. It is ultimately at the discretion of the Governor to release the funds for each project.

Line items indicate "earmarked" operating funds from the general appropriations that are to be spent on specific programs or projects. These items are not found anywhere in the body of Act 243. 
