This description represents a verbal
delineation of the inland boundary of the Louis-
iana coastal zone. The boundary was originally
delineated on the 7 1/2 or 15 minute quadrangles
listed at the end of this description. The

Coastal Zone (Sea Grant Publ. No. LSU-T-75-006), was delineated on a 1:250,000 map series published by the U.S. Geological Survey and photographically reduced to publication size. This written description, therefore, represents a degree of accuracy and precision not attainable from the original report.

The alternate description on page 8 of this report outlines the boundary as presented in the original report. Recent developments, however, indicate the inclination of proposed legislation to define the boundary to include only that part of the Atchafalaya Basin south of Interstate Highway 10. Elevations north of this point are consistently above 5 feet. This verbal delineation, therefore, presents both alternative plans to insure completions.

No. 190; thence with the Centerline of said Highway No. 190 across Bayou Liberty to the 5-foot contour on the left descending bank of said Bayou; thence down the 5-foot contour on the left descending bank of said Bayou to the Centerline of the Highway connecting the Settlement of Bonfouca with the City of Slidell; thence East along said Highway to the Centerline of the Southern Railroad; thence Southwest along the Centerline of said Railroad to the Corporate limits of the City of Slidell; thence South and East with the Corporate limits of Slidell to the Centerline of U.S. Highway No. 11; thence in a Southerly direction with said Highway No. 11 about one-quarter (0.25) mile to the Centerline of a drainage canal; thence Easterly with the Centerline of said canal to the West line of Section 25 Township 9 South Range 14 East; thence North along the West line of Sections 25 and 24 to the Southwest corner of Section 13; thence East along the South line of Section 13 to the line between Ranges 14 and 15 East; thence East along the South line of Section 18 to the Southeast corner of Section 18 in Township 9 South Range 15 East; thence North along the East line of Section 18 to the Y-road intersection at the Southernmost corner of Section 37; thence Northerly along the West branch of said road fork to the line between Townships 8 and 9 South; thence Northerly along the same road to the Southeast line of Section 31; thence Northeast along the Southeast line of Section 31 to the East line of said Section 31 in Township 8 South Range 15 East; thence North along the East line of Sections 31, 30, and 19 to the Northeast corner of Section 19; thence West along the South line of Section 18 to the line between Ranges 14 and 15 East; thence North along said Range line to the Centerline of U.S. Highway No. 11; thence Easterly along the Centerline of said Highway No. 11 to the Louisiana-Mississippi State Boundary in the middle of the Easternmost Branch of the Pearl River.
